Invitation to Bid for the PIPELAYING OF 100MM PARALLEL PIPELINES IN BACAG WEST-HIGHWAY in Barangay Bacag West, Villasis, Pangasinan

1. The VILLASIS WATER DISTRICT, through the 2020 CORPORATE BUDGET APPROVED BY THE GOVERNING BOARDS intends to apply the sum of ONE MILLION ONE HUNDRED FIFTY NINE THOUSAND FOUR HUNDRED THIRTY SIX PESOS AND 25/100 (PHP 1,159,436.25) being the Approved Budget for the Contract (ABC) to payments under the contract for **PIPELAYING OF 100MM PARALLEL PIPELINES IN BACAG WEST-HIGHWAY in Barangay Bacag West, Villasis, Pangasinan.**
2. Bids received in excess of the ABC shall be automatically rejected at bid opening.
3. The VILLASIS WATER DISTRICT now invites bids for **PIPELAYING OF 100MM PARALLEL PIPELINES IN BACAG WEST-HIGHWAY in Barangay Bacag West, Villasis, Pangasinan.** Completion of the Works is required **FORTY FIVE (45) CALENDAR DAYS.** Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
4. Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act.”
5. Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
6. Interested bidders may obtain further information from **VILLASIS WATER DISTRICT** and inspect the Bidding Documents at the address given below from **MONDAY TO FRIDAY, 8:00 AM TO 5:00 PM.**
7. A complete set of Bidding Documents may be acquired by interested bidders starting on **JULY 30, 2020** from the address below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of FIVE THOUSAND PESOS (PHP 5,000.00)* for new bidders while those who have already bought the said bid documents are no longer required to pay such fee.

8. It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.
9. Bids must be duly received by the BAC Secretariat at the address below on or before **AUGUST 19, 2020; 10:30 AM**. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on **AUGUST 19, 2020 10:35 AM** at the **VWD BOARDROOM**. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

10. The **VILLASIS WATER DISTRICT** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
