## Invitation to Bid for "Design and Build" Contract for Dasol Water District Water Supply System Improvement Project -GAA 2017 Funded"

- 1. The Villasis Water District, through the General Appropriations Act (GAA) 2017 intends to apply the sum of Twelve Million Five Hundred Eighty-Nine Thousand Nine Hundred Ninety-Three Pesos and 88/100 centavos (PhP 12,589,993.88) under the contract for Design and Build" Contract for Dasol Water District Water Supply System Improvement Project -GAA 2017 Funded. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The *Villasis Water District* now invites bids for the above Procurement Project. Completion of the Works is required *360 days*. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
- 4. Interested bidders may obtain further information from *Villasis Water District* and inspect the Bidding Documents at the address given below from *Mondays to Fridays from 8:00AM to 4:00PM*.
- 5. A complete set of Bidding Documents may be acquired by interested bidders starting on *July 05, 2021* from given address and website/s below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of *Twenty Thousand Pesos (PhP 20,000.00)*. The Procuring Entity shall allow the bidder to present its proof of payment for the fees.

- 6. The *Villasis Water District* will hold a Pre-Bid Conference<sup>1</sup> on *July 13, 2021 at 10:00:00AM* at *Fiesta Grande Beach Resort, Macalang, Dasol, Pangasinan* which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat through *manual submission* at the office address as indicated below *on or before July 26, 2021 at 9:00:00AM*. Late bids shall not be accepted.
- 8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 16.
- 9. Bid opening shall be on *July 26, 2021 at 9:05:00AM* at the given address below at the *Villasis Water District Boardroom, Poblacion Zone I, Villasis, Pangasinan.* Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
- 10. The *Villasis Water District* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
